Gayatri Seva Sansthan, (DMO) - SCI are hereinafter, collectively referred to as "Parties" and individually as a "Party"

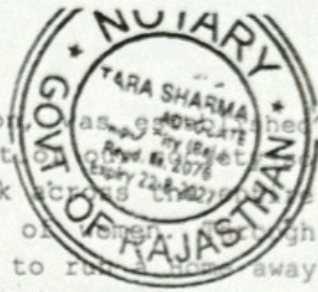

Gayatri Seva Sansthan, a non-profit organization, as a change, has been established pertaining the vision to aid the indigent segment of the population. We work across a spectrum of health, education, and empowerment of women. Through its signature program SEVA GAYATRI Home, we aim to run a home away from Homes to provide support in accommodation to the cancer patients and the family, from moment of detection, through diagnosis, and treatment.

A 'State Cancer Institute' is opened on the premises of Rajasthan University of Health and Sciences (RUHS) in Pratap Nagar. Hospital administration oversee the project. The institute offers advanced technological amenities and treatments to the cancer patients. The sections of the institute include Radiotherapy, medical oncology, surgical oncology, nuclear medicine, pathology and radio diagnosis.

In 2023, Rajasthan had 2.3 Lakh cancer patients with 40,000 new cases being added each year, the goal is to ensure that while enduring the rigor of the disease one shouldn't have to agonize themselves with the fear of being homeless.

C.

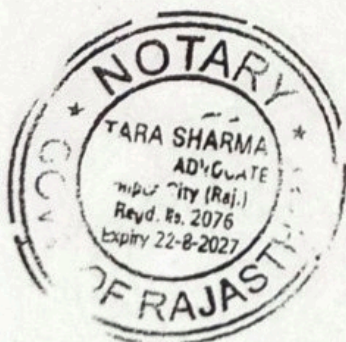
Gayatri Seva Sansthan, and SCI have mutually agreed to collaborate with each other on driving Change for people suffering from cancer at State Cancer institute.

6.1 Gayatri Seva Sanstha will make payment to the Social Support Team and vendors directly.

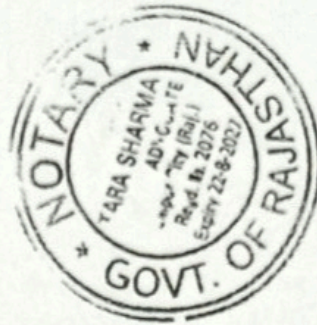

LIMITATION OF LIABILITY:

i.

The Social Support Team made available by Gayatri Seva Sansthan to the Hospital shall function as a support to the Treating Doctors and Para Medical Staff of the Hospital. The Social Support Team shall neither be authorized to prescribe any medicines, investigation/diagnostic tests to the patients nor act in any manner whatsoever on behalf of the Hospital.

ii.

Any and all medical staff including Nurses deployed under this MOU shall be appointed in accordance with the recruitment procedures & Hospital. It is agreed between the parties that such medical staff including Nurses shall be governed as per the rules and regulations of the Hospital and the Hospital shall be solely responsible in all matters pertaining to their work, conduct and effects of their actions at the workplace. Gayatri Seva Sansthan's role in the enabling of such staff will be limited solely to the administration of their salaries and, wherever applicable, related benefits, as set out in this MOU and to the determination of the level of such salaries and benefits.

Subject to above, the Hospital shall not have any financial liability towards Gayatri Seva Sansthan as part of this MoU.

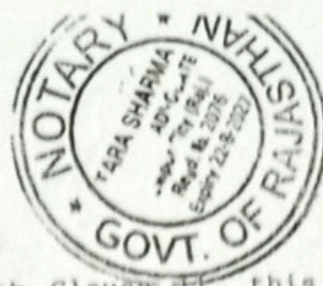

Renewal of the MOU will be subject to suitable reports and proper documentation of the progress made.

Both parties agree to provide information and reporting on the programs and activities undertake weekly reports on daily activities; the report template will be provided via email after project commencement.


11. TERMINATION:

This MOU may be terminated:

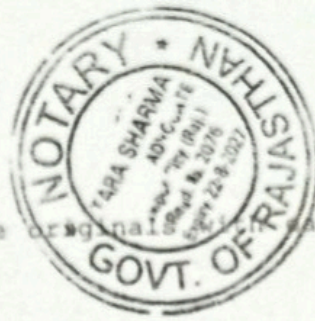
1. by mutual agreement between the Parties which shall be recorded in writing;

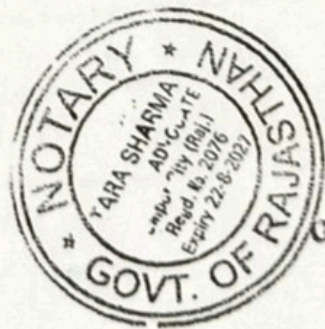
